TOURNAMENT PREVIEW

This is a competitive golf tournament for players of all abilities, with top prizes, that raises money for our selected charity, the Fairway Foundation. This organization, created by the 3M Championship (formerly the Burnet Senior Classic), the Minnesota Golf Association, and the Minnesota Section of the PGA, introduces inner city youth to golf and the benefits that come with the game.

TOURNAMENT FORMAT

Play will be in the 6-6-6 medal play format (best-ball, scramble, alternate shot). The team handicap is established by adding (or averaging) both handicaps together; however, there is a maximum of 10 points between the two handicaps. The tournament will be flighted.

ELIGIBILITY

Open to all female amateur players who have an established USGA handicap (GHIN, NGN, or other) or provide an 'average' score for 18 holes and a 'handicap index' will be assigned to them. The USGA's definition of an amateur golfer is the standard of the tournament. All entries are subject to approval or rejection at any time by the Tournament Committee.

RULES

USGA Rules shall govern play. Local rules will be printed and issued to each player.

CARTS/CADDIES

Carrying your bag is permissible as is using a pull cart. Motorized riding carts must be reserved in advance and indicated on the entry application. The cost of a motorized cart at Bunker Hills is \$15 per person and must be paid on the day of the tournament.

ENTRY DEADLINE, ENTRY FEES AND GREENS FEES

Entry forms must be postmarked by Friday, June 15, 2007. An entry fee of \$120 (\$60 per player) must accompany the entry form. Greens fees are included. Late or incomplete entries are not acceptable. Entries by telephone or FAX are not acceptable. Entries with insufficient funds will be considered incomplete and withdrawn.

STARTING TIMES

Assigned starting times can be obtained after noon on Wednesday, June 20 by accessing the EWGA website at www.mnewg.org Starting times will be late morning.

ENTRY WITHDRAWAL AND REFUNDS

Entry fee will be refunded, regardless of reason, if the EWGA is notified in writing before the close of entries. After the close of entries, the entry fee will be refunded in the event of injury or illness only if the EWGA is notified by phone at 952-934-3143 by Friday, June 22, 2007, by 4 p.m. If this event is cancelled due to weather, all but \$20 will be returned.

PRIZES

Appropriate merchandise certificates will be awarded as determined by the Tournament Committee. Merchandise certificates will be available at the close of play at Bunker Hills.
